- Allows school counselors and social workers to keep Transgender secrets from parents.
- Deems parents who do not agree with the Transgender social contagion as “unsafe and abusive.”
- Justify hiring more school counselors and social workers because they are required to spend 80% of their time “working” with students.



# STEP 1

## ***SECRETS FROM PARENTS***



- Allows minors to travel across state lines to obtain Transgender drugs and surgeries.
- Parents will be denied custody if they do not support Transgender procedures.
- Will not honor custody agreements of the parents' home state.

# Consent

- 16-year-olds or younger will not need parental consent to obtain irreversible Transgender drugs
- Children 8-years-old or younger will be able to consume irreversible Transgender puberty blockers with parental consent.
- Protects hospitals and doctors from future lawsuits due to Transgender damages.

*\* Transgender surgeries without parental consent for minors will be the next escalation.*

# LEGISLATIVE STEPS FOR SEPARATING CHILDREN FROM PARENTS

*Legislative bills will collaboratively aim to expedite the process of separating children from parents by using Transgenderism as a justification.*

**STEP 1** is foundational legislation because it allows Transgender secrets to be kept from parents by K-12 school counselors, social workers, and teachers. The underlying justification of these bills rests on the unfounded assumption that parents who do not affirm their child's manufactured gender identity are inherently "unsafe and abusive." The prevailing school environment fosters the spread of Transgender social contagion among students while portraying parents as a potential threat. These bills are recruitment efforts for the Transgender Cult.

**STEP 2** enables the state to intervene in cases involving out-of-state children, allowing for the potential removal of parental custody if the parents do not support horrific Transgender drugs or surgeries. Moreover, these bills disregard any existing custody agreements from the parents' home state, opting instead to place the children in foster care until the completion of transgender treatments. This legislation is state-sanctioned trafficking. The underlying rationale for these bills is an extension of the flawed premise established by STEP 1 bills, which falsely portray parents as being unsafe, abusive, and potentially endangering their children's lives by not consenting to irreversible and harmful Transgender procedures.

**STEP 3** is to lower the age of consent regarding irreversible puberty blockers and cross-sex hormone drugs. Under these bills, a 16-year-old or younger would be able to initiate Transgender medication without parental consent. Additionally, it permits 8-year-olds and younger to undergo transgender treatments with the approval of their parents. Furthermore, these bills create additional obstacles in pursuing legal action against doctors and clinics in the future, particularly when individuals realize the implications of the procedures they have undergone during their childhood. (Transgender surgeries without parental consent for minors will be the next escalation.)

**STEP 4** is legislation that allocates taxpayer funds to cover the expenses of Transgender medications and surgeries outlined in STEP 2 and STEP 3. This enables hospitals and clinics to receive reimbursement through Medicaid. It's important to note that, similar to the standard Medicaid requirements, families above a specific household income threshold will not be eligible. However, in cases where children are removed from parental custody, they will qualify for coverage. Additionally, under these bills, a minor's immigration status will not disqualify them from utilizing Medicaid for Transgender-related drugs or surgeries.

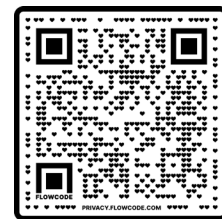
